Additional information

► Do I need a certificate of recognition of study periods (*Studienzeitanrechnungsbescheinigung*)?

Yes, if you change the weighting of your study course: when you increase the percentage of your study course you do need the recognition of study periods, when you decrease the percentage, no recognition is needed.

Yes, if you change to a similar or neighbouring subject (e.g. from *Japanologie* to *Ostasienwissenschaft*) and wish to have coursework accredited

Yes, if you have completed coursework in a study programme you have not yet been enrolled in and wish to have this coursework accredited.

► Do I need to see a departmental student advisor (*Fachstudienberater*), and why?

An advising meeting is obligatory if, in the semester you wish to change your study programme, you are in your third or higher subject-related semester (*Fachsemester*) in the major/minor you wish to change.

You must present proof of an advising meeting with the departmental student advisor of your new major/minor when you hand in the form "Application for change of major/minor."
