- Can be taken out up to the age of 74 (up to the insured person's 75th birthday)

CARE COLLEGE

- Foreign travel health insurance, Care-College specialized in foreign language students, university students, Scholars and Ph.D. students, participants in international projects of universities and colleges of higher education (Fachhochschulen) during their stay in Germany
- Duration of contracts 1 month up to 4 years
- Can be take out up to the age of 40

- Foreign travel health insurance including personal accident and liability insurance
- Offers insurance coverage for language students, trainees and visiting scholars
- Combined insurance covers main risks
- Can be taken out up to the age of 69

Note for third-country nationals with a research visa (without working contract)

Since March 2024 third-country nationals with a residence permit as a researcher (§18d German Residence Act) can also take out German state-regulated health insurance on a voluntary basis. Registration must take place within three months of entry. Under certain circumstances this could be a good option. The Welcome Centre will be happy to advise you.
