

Coronavirus Regulations for On-campus Classes and Events at Heidelberg University

9 November 2021

The regulations presented here are based on the current versions of the Coronavirus Ordinances of the State of Baden-Württemberg for the **Warning Level**. For all listed categories of classes/events, the rule is – unless otherwise stated – that it is necessary to respect the minimum distance, to collect contact details and to comply with the hygiene plan.

Participant limit: Includes those who have been vaccinated and who have recovered

3G rule: Presenting and checking of up-to-date negative test, or certificate of vaccination or recovery, by all participants; "PCR certificate only" = Access only with up-to-date negative PCR certificate, or certificate of vaccination or recovery, Rapid antigen tests will no longer be sufficient.

2G rule: Presenting and checking of certificate of vaccination or recovery, by all participants; non-immunised active participants have to present a negative test certificate

Mandatory mask: No mandatory mask for lecturers if required distance can be observed; exclusively medical masks (OP masks or FFP2 without vent)

Rectorate approval: Submission via Division 1

Occupation of space: Percentages of space utilization refer to the permitted capacity of the venue

* = Applies to all participants and contributors. May as appropriate, be waived at examinations by compliance with minimum distance or the mandatory mask.

** = No mandatory mask when seated during examinations.

*** = The minimum distance may be waived, then wearing a mask is mandatory in every case
